Greenwood Country Club Rules

It is the responsibility of all Greenwood Country Club (use further will be noted as GCC) members and their families to know and conform with the rules and regulations adopted by the Board of Governors. Members and their guests are expected to behave in an exemplary manner at all time. They should follow the accepted standards of courtesy, conduct, dress, and good manners that help make the club a source of pride and pleasure, to all its membership. The rules contained herein will be strictly enforced. Failure to comply could result in fines, suspension, or expulsion.

House Rules

1. Hours of Operation

The country club's hours are from 9am – 10pm, unless prior arrangements have been made with the clubhouse manager, the clubhouse is secured after the last member leaves the property each business day Tuesday – Sunday. All parties shall terminate at midnight with the exception of club functions. Club functions shall terminate not later than 1:00am, and the club must be vacated by 1:30am. The clubhouse bar will be open six days a week – closed on Mondays. The dining facilities will be closed on Sunday evenings, Mondays all day, and Tuesday evenings. During the swimming season, the snack bar will be open 11am – 6pm Tuesday – Saturday and 1pm – 6pm on Sundays.

2. Use of the Club

A. Members and Guests

Only members in good standing and their immediate families and guests, who must reside outside of Leflore County and outside a 25 mile radius from Greenwood, may use the facilities of the club. However, when a member of the club is entertaining at his own expense in the clubhouse, he may invite, to the club's dining facilities, subject to the rules herein, his personal non-member guests whether resident or non-resident, unless specifically stated otherwise in announcement of special club functions. These guests may not include past members of the club who have been expelled for any reason. Non-member Leflore County residents and anyone living within a 25 mile radius of GCC are not permitted to use the golf course, the tennis courts, racquetball courts or swimming pool except for one visit per year as a prospective member or as a guest of a family member. Members are required to register their guests with the appropriate department head or with the General Manager immediately upon entering the premises of the club, and the member shall likewise attach his own signature as host. Members are both responsible both for all debts incurred and all acts committed by their guest while on the club premises.

3. Private Parties For Members Only

- A. Reservations for private parties or dances must be made in advance with the General Manager and may be made without prior approval of the house committee. All functions must be bona-fide parties of members sponsoring and attending such party. Members not

canceling private party reservations are responsible for any expenses incurred by the club in preparation for the party.

No member of the club can engage the club for more than one date, and all reservations shall be accepted by the General Manager on the order in which they are received. Any member has the right at all times to inspect the reservation book. Members are requested to cancel any reservation not needed at least one week prior to the date of the reservation.

The club is not available for private parties on Thanksgiving, December 23, 24, 25th, January 1st, or any holiday or occasion that the Board of Governors declares necessary for club entertainment.

Damage or breakage of any club property by a member or his immediate family or guests shall be paid by the member and any member having made reservations for use of the clubhouse is responsible for any damage to the club property which may occur. There will be no ballroom rental charge or room charge for members. Member sponsored events for non-members will incur a room rental fee.

B. Private Parties for Organizations, Associations, or Non-Members

Any group with non-member guests must be sponsored by a current member or members in good standing. Said member or members of the club shall request such reservations in writing at a regular meeting of the Board of Governors. If Board approval is received, such member or members shall assume full responsibility for proper care and preservation of club properties, including the cleaning hereof after use. The Board of Governors shall assess any unusual expenses incurred through the neglect or failure of such member or members promptly and shall levy an adequate fine to cover same.

Publications, whether appearing in newspapers or invitations in regard to private parties must list the member(s) name(s) ONLY and not bear a group or club's name as the sponsor of such party.

There will be a \$500.00 ballroom rental fee charged for non-member usage of the facility. This fee may be waived or reduced for private events, based upon the volume of Food and Beverage purchases.

C. Catering

All catering is to be by the country club. In the event that the nationality or cultural food is unable to be provided by the Executive Chef, at that point can permission be given to sell the kitchen space out to an outside licensed and bonded caterer. Outside servers are not permitted unless contracted by the country club to service events. All arrangements for service must be made through the General Manager and Events Coordinator. Cakes are permitted to be furnished by members. Food services are available for all parties with the fee to be agreed upon between the member and General Manager.

D. Decorations

All decorations for parties must be approved by the General Manager. If the club is decorated for private events, all decorations must be freestanding and not involve loose materials such as glitter or confetti, and may not be taped, stapled, tacked on to any surface of the club.

E. Bars and Drink Tickets

Private Events have the option of electing to have a number of drink services. The minimum fee for each bar setup is \$150 per bar. The host of the party can choose to host a cash bar or an open bar. The culinary team can also provide specialty drinks, or prepaid tickets.

4. Conduct of Members

- A. No member shall take away from the clubhouse any property belonging to the club and no equipment of the club shall be loaned or rented under any condition by the members, golf professional, or manager.
- B. No one shall be allowed in the clubhouse in a bathing suit or without a shirt or shoes.
- C. No pets of any description other than registered service animals shall be allowed in the clubhouse, locker room or anywhere on the club grounds unless permission is granted by the Board of Governors.
- D. Members shall not reprimand an employee of the club.
 - (1) Slow, unsatisfactory, improper, or discourteous service should be reported to the General Manager.
 - (2) Complaints of a serious nature should also be submitted in writing to the Board of Governors President as soon as possible.
- E. Members are responsible for the conduct of their children, and any misconduct or misuse of the club facilities by children is to be reported by the staff to the house committee. Parents giving children's parties are cautioned to see that the children do not damage the club property. All such children's parties are to be properly chaperoned.
- F. Parking is allowed only in designated parking areas. No parking is allowed at any time in front of the clubhouse on the drive.
- G. No member or club employee shall have any advertising circular or subscription paper displayed without the express permission of the Board of Governors.
- H. It is requested that charge tickets be signed and the member's account number be listed. No one may use another member's account number without prior consent of that member.
- I. Members are to make arrangements for food and drinks through the facilities of the club. Violations of this rule will result in a fine imposed by the Board.
- J. Any infringement of the rules of the club shall be subject to discipline by the Board of Governors according to the bylaws of the club.
